Dear Chairman Wicker and Ranking Member Cantwell:

We write to you to express our serious concerns regarding reports¹ that the White House is considering nominating Dr. Nancy Beck to be chairman of the Consumer Product Safety Commission (CPSC).² Throughout her career, Dr. Beck has opposed and weakened safety standards that impact our health, safety, and environment, particularly with respect to toxic chemicals. If nominated and confirmed to lead the CPSC, she will have a perch to do even more damage to public health and consumer protection for many years. This is unacceptable.

The CPSC's jurisdiction is vast. It is responsible for protecting consumers against "unreasonable risks of injury or death" from consumer products,³ with responsibility for ensuring that more than 15,000 products are safe, including toys, household chemicals, furniture, and all-terrain vehicles. From lead paint to flame retardants to toxic per- and poly-fluoroalkyl substances (PFAS) to asbestos, Dr. Beck has fought against safeguarding the public from dangerous chemicals found in consumer products.

A congressional investigation found that Dr. Beck improperly intervened in agency decisions and scientific determinations when she worked as a policy analyst in the Office of Management and Budget (OMB) during the Bush administration.⁴ More recently, as an official at the Environmental Protection Agency (EPA), she has been the architect of numerous policies to

undermine health protection from toxic chemicals that would protect servicemembers, children, and at-risk communities. If nominated and confirmed, there is strong reason to believe that Dr. Beck would use the same zeal for weakening safety standards as she has done in previous government posts; but would have even more power to do so.

In particular, we fear that if Dr. Beck were CPSC chair, she would undermine efforts to protect consumers from PFAS, a class of persistent and toxic chemicals that have been linked to testicular and kidney cancer, birth defects, and immune system disorders and other health effects.⁵ PFAS are found in many consumer products as well as firefighting foam that is used on military bases. The "Defense Department listed 126 facilities where tests of nearby water supplies showed the substances exceeded the current safety guidelines." There is strong bipartisan concern about PFAS contaminating drinking water across the country, including at dozens of military bases. While at EPA, Dr. Beck assisted in delaying the release of a government study on the risks posed by PFAS which the White House deemed a "public relations nightmare."

Between her stints at OMB and EPA, Dr. Beck was a senior executive at the American Chemistry Council, a powerful chemical industry lobbying group. This is important because the CPSC has jurisdiction to safeguard consumers from products that are hazardous due to the presence of chemicals. The CPSC has issued a rule limiting the use of phthalates in children's products and is currently considering a rule limiting the use of organohalogen flame retardants in certain products. The American Chemistry Council has ardently opposed these protections, which have significant impacts for the health and safety of consumers. We are concerned that Dr. Beck will thwart the CPSC's ability to protect consumers from the well documented harms that these chemicals pose.

If nominated and confirmed, Dr. Beck could be one of the most egregious examples of the proverbial fox guarding the henhouse. The CPSC is already hamstrung by laws that make it hard for the agency to robustly protect families from unreasonable injury and death. For example, recent reports have shown how a little-known provision of the law stopped the CPSC from

informing the public about how inclined sleep products were linked to the deaths of more than 70 infants.⁸ The agency has also come under fire for working with a stroller company to evade undergoing a recall for faulty parts that contributed to injuries of more than a hundred children and adults.⁹

Giving Dr. Beck a post to slow down, weaken, or kill safety standards will have a lasting impact. Nothing less than the safety of your constituents is at stake. We urge you to make clear that you stand with our families, our children, our servicemembers, and our environment and oppose this nomination. With questions, please contact Remington A.
