

REGULATION OF THE PRESIDENT OF THE REPUBLIC OF INDONESIA ON THE NATIONAL AIDS COMMISSION

WITH THE MERCY OF GOD ALMIGHTY

THE PRESIDENT OF THE REPUBLIC OF INDONESIA

Considering:

- a. that within the framework of efforts to enhance the prevention, control and management of the response to AIDS, strategic steps need to be undertaken to assure the continuation of AIDS prevention and to avoid greater impact in the fields of health, social affairs, politics and economics;
- b. that within the framework of efforts to increase the effective coordination of AIDS in order for prevention to be more intensive, holistic, and integrated, it is necessary to clarify the duties of the National AIDS Commission established under Presidential Decree No. 36/1994 on National AIDS Commission:

In view of : Article 4 Paragraph (1) of the Indonesian Constitution of 1945;

DECIDES:

To stipulate: PRESIDENTIAL REGULATION ON THE NATIONAL AIDS COMMISSION

CHAPTER I ESTABLISHMENT, POSITION AND DUTIES Article 1

Within the framework of efforts to promote more intensive, holistic, integrated and coordinated prevention and management of the response to AIDS, a National AIDS Commission is established.

Article 2

The National AIDS Commission shall be under and responsible to the President.

Article 3

The National AIDS Commission shall have the duties of:

- a. Stupulating national strategic policies and plans as well as general guidelines for preventing, controlling and managing the response to AIDS;
- b. Stipulating strategic steps required to implement activities;
- c. Coordinating the implementation of activities for provision of information, prevention, delivery of services, monitoring, controlling and managing the response to AIDS.
- d. Disseminating accurate information on AIDS to a wide range of .mass media in such q way as not to result in social unrest:

- e. Undertaking regional and international cooperation within the framework of efforts to prevent and manage the response to AIDS;
- f. Coordinating the management of data and information on issues related to AIDS:
- g. Controlling, monitoring and evaluating the implementation of activities for prevention and management of the response to AIDS;
- h. Providing direction to AIDS Commissions at the Provincial and District/City levels respectively within the framework of efforts to prevent, control and manage the response to AIDS.

CHAPTER II ORGANIZATION Part 1 Membership Article 4

1. Membership of the National AIDS Commission shall consist of:

 - m. Cabinet Secretary; Panglima Tentara Nasional Indonesia;
 - n. The Indonesian Armed Forces Chief;
 - o. The National Police Chief;
 - p. Head of the Agency of the Assessment and Application of Technology;
 - q. Head of the National Family Planning Board;
 - r. Chairperson of the National Narcotics Board;
 - s. Chairperson of the Executive Board of the Indonesian Doctors Association;
 - t. Chairperson of the Indonesian Public Health Specialist Association;
 - u. Chairperson of the Indonesian Red Cross;
 - v. Chairperson of the Chamber of Commerce and Industry;
 - w. Chairperson of the national Organizations of People Living with AIDS (PLWA)
- 5. Secretary, and Member

- 2. Membership of the National AIDS Commission as mentioned in paragraph (1) may be increased by the Chairperson of the National AIDS Commission.
- 3. Change in the name of the Secretary as mentioned in paragraph (1) item 5 shall be made by the Chairperson of the National AIDS Commission.

Part 2 Executing Team Article 5

- 1. Implementation of the daily duties of the National AIDS Commission shall be supported and undertaken by an Executing Team.
- 2. The Executing Team as mentioned in paragraph (1) shall be chaired by the Secretary of the National AIDS Commission.
- 3. Membership of the Executing Team as mentioned in paragraph (1) and (2) shall consist of officials of the related agencies, professional organizations, professional staff and other relevant parties decided by the Chairperson of the National AIDS Commission.

Part 3 Working Groups and Expert Panels Article 6

- 1. To facilitate implementation of the work of the National AIDS Commission, the Chairperson may establish Working Groups and/or Expert Panels.
- 2. Membership of Working Groups and/or Expert Panels as mentioned in paragraph (1) shall consist of officials from the related government agencies, experts, academicians, practitioners, and/or other parties as deemed necessary.
- 3. Guidelines on membership and working procedures of the Working Groups and/or Expert Panels as mentioned in paragraph (1) and (2) shall be stipulated by the Chairperson of the National AIDS Commission.

Part 4 Secretariat Article 7

- 1. In undertaking its duties, the National AIDS Commission shall be supported by a Secretariat.
- 2. Organization and personnel as well as the working procedures of the Secretariat as mentioned in paragraph (1) shall be stipulated by the Coordinating Minister of People's Welfare as Chairperson of the National AIDS Commission.

CHAPTER III PROVINCIAL AIDS COMMISSION AND DISTRICT/CITY AIDS COMMISSION Article 8

- 1. For smooth implementation of the duties of the National AIDS Commission, Governors and District Heads/Mayors shall establish Provincial AIDS Commissions and District/City AIDS Commissions respectively.
- 2. The Provincial AIDS Commission as mentioned in paragraph (1) shall be chaired by the Governor.
- 3. The District/City AIDS Commission as mentioned in paragraph (1) shall be chaired by the District Head/Mayor.

Article 9

The Provincial AIDS Commission and the District/City AIDS Commission shall have the responsibility of formulating the required policies, strategies and steps fro prevention of AIDS in the respective areas in accordance with the policies, strategies and guidelines by the National AIDS Commission.

Article 10

- 1. The Provincial AIDS Commissions and the District/City AIDS Commissions shall on a periodic basis report the implementation of their duties to the Chairperson of the National AIDS Commission.
- 2. Provisions on reporting procedures shall be determined by the National AIDS Commission.

Article 11

Provisions the working procedures of the Provincial AIDS Commissions and the District/City AIDS Commissions shall be regulated by the Governor, District Head and Mayor respectively based on working procedures stipulated by the National AIDS Commission.

CHAPTER IV WORKING PROCESS Article 12

In undertaking its duties, the National AIDS Commission shall coordinate and/or cooperate with the Central and Local Government agencies, the business world, non-governmental organizations, universities, international agencies, and/or other related parties as appropriate, san shall involve people's participation as well.

Article 13

The National AIDS Commission shall report to the President at least once in three months on implementation of their duties or at any time, as requested.

Article 14

Additional provisions on working procedures of the National AIDS Commission may be issued by the Chairperson of the National AIDS Commission.

CHAPTER V FUNDING Article 15

- 1. All of the costs required for carrying our the work of the National AIDS Commission shall be borne by the State Budget and other non-binding funding sources in accordance with the existing laws and legislation.
- 2. All of the costs required for carrying out the work of the Provincial AIDS Commission shall be borne by the Provincial Budget.
- 3. All of the costs required for carrying our the work of the District/City AIDS Commission shall be borne by the District/City Budgets.

CHAPTER VI TRANSITIONAL PROVISION Article 16

With this Presidential Regulation coming into effect, all activities of preventing and managing the response to AIDS which were the responsibility of the National AIDS Commission established by the Presidential Decree No. 36/1994 on the AIDS Commission, shall be assumed and completed by the National AIDS Commission established by this Presidential Regulation.

CHAPTER VII CLOSING PROVISIONS Article 17

As required, more detailed provision for implementing the Presidential Regulation shall be stipulated by the Coordinating Minister for People's Welfare as the Chairperson of the National AIDS Commission.

Article 18

With this Presidential Regulation, coming into effect, Presidential Decree No. 36/1994 on AIDS Commission shall be revoked and is no longer valid.

Article 19

This Presidential Regulation shall take effect as of the date of stipulation.
