
Dear Governor Locke:

Thank you for your letter of June 17, 2004, in which you clarified Washington's position regarding the extension of the state's government procurement commitments under the World Trade Organization Agreement on Government Procurement to certain countries with which we have recently concluded free trade agreements.

I appreciate that Washington's procurement commitments under these agreements do not apply to the policies that you identify in your letter. We do not believe it is necessary to alter Washington's exemptions under these agreements in light of the clarifications in your letter. However, we recognize and respect your decision to limit the coverage of Washington's procurements. As I stated in my September 2003 letter to you, it is up to each state to decide whether to cover its procurement under our trade agreements, and the extent of any such coverage.

Washington's commitment to cover its state procurement under our free trade agreements with Australia, Morocco, and the Central American countries provided important leverage for the United States in negotiating access to the sub-central entities of those countries. By agreeing to be bound by these agreements, the State of Washington helps open markets for U.S. exporters, including those in your state.
