Secretary Kristi Noem has instructed TSA and airports across the nation to air a video inside the airport that warns airline passengers of additional dangers they face in flying during the government shutdown, such as many security operations of TSA have been impacted by the shutdown and most TSA security peronnel are working without pay. The video then blames the Democrats for the government shutdown and these additional lapses in security.

Notably, many airports are refusing to show the video because it violates the Hatch Act and is irresponsible.
