Figure One: Total Points, by Category

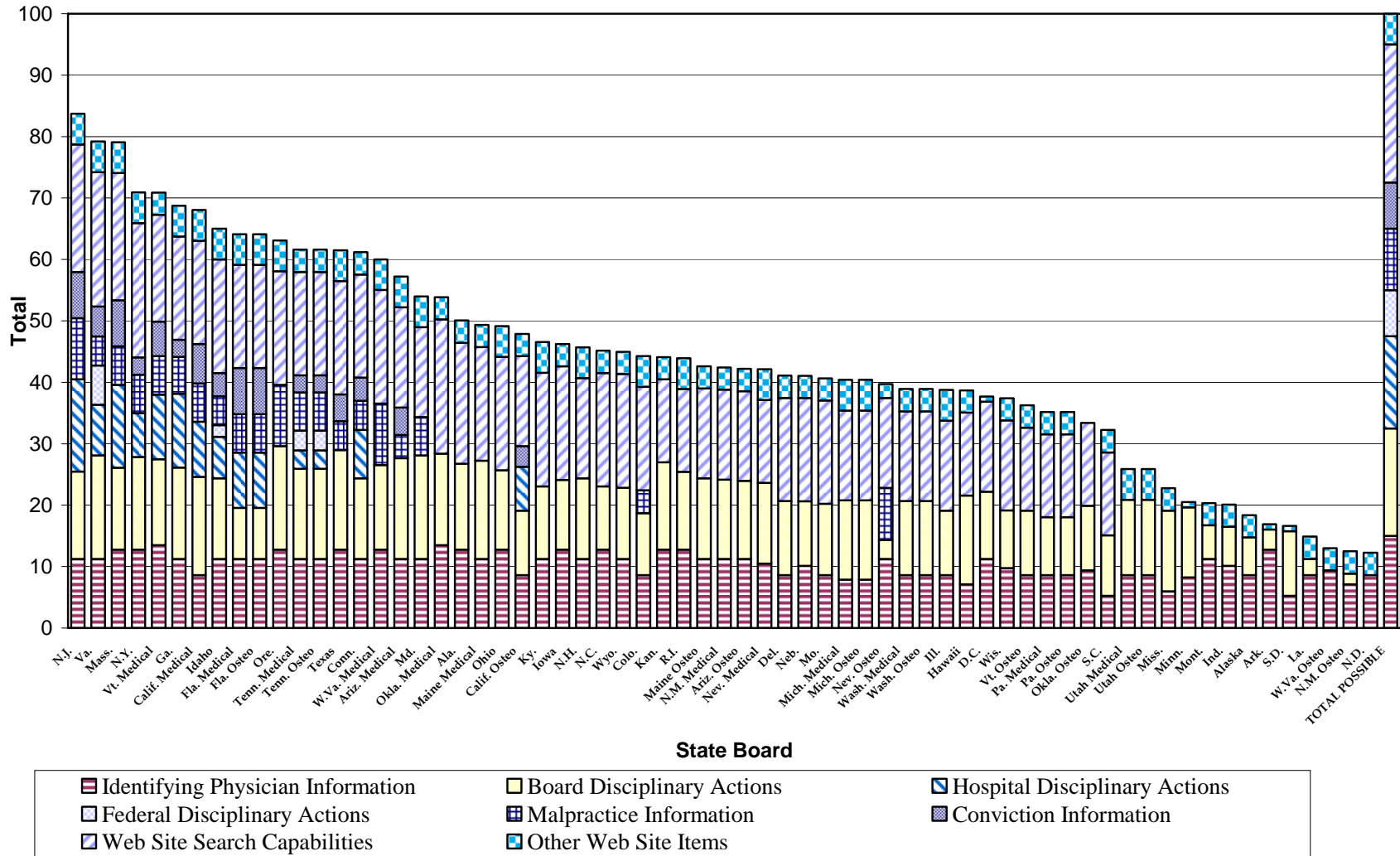

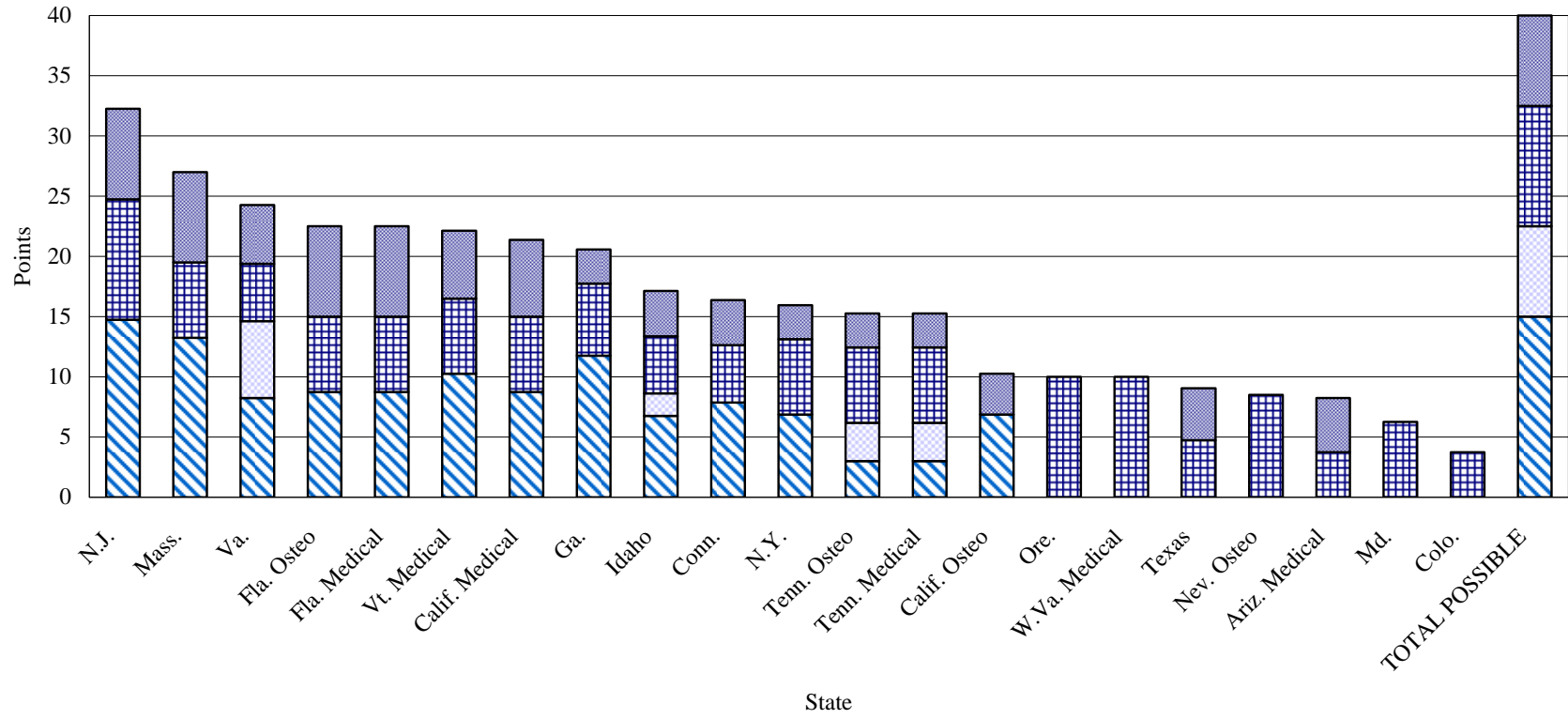
