***Data Fields Defined:***

**TA-W Number:** A five digit number assigned to each case that is automatically generated by the MIS when data related to a new case is entered.

**Company Name:** The name of the company employing the petitioning worker group.

**Second Name:** Division within the company or D/B/A.

**Address:** Company location.

**City:** Company location.

**State:** Company location.

**Zip:** Company location.

**Product (P) or Service (S):** Product(s) produced or services provided by the petitioning worker group.

**Petitioner Type:** Three Workers, Company Official, Union Official, State Workforce Office, One-Stop Operator/Partner, Other Authorized Representative.

**SIC:** The Standardized Industrial Classification System: This four digit code is designed to track the industry of the petitioning company. This code was replaced by NAICS but is still tracked because it dates back to the beginning of the program.

**NAICS:** The North American Industry Classification System.

**Petition Date:** The date that the petition was signed by the petitioner(s) (This is not the date it is received by OTAA).

**Institution Date:** Date that OTAA accepts the petition as properly filed and begins the investigation. (This is not the date it is received by OTAA)

**Determination Date:** Date when determination was signed by the Certifying Officer.

**Determination Code:** Code that represents: (a) the types of certification, (b) a denial, or (c) termination of the determination.

**Impact Date:** The date stated in a certification of eligibility to apply for TAA on which the total or partial separations of the workers covered by the certification began or threatened to begin. This date cannot be more than one year prior to the date of the petition.

**Expiration of Determination Date:** Date at which the certification expires, usually, two years after the determination date.

**Estimated Number of Workers:** Estimated number of workers that have been separated from trade affected employment as calculated during the investigation. This number includes employment reductions through attrition and is not a calculation of layoffs.

**Number of ATAA Workers:** Estimated number of workers eligible for ATAA based on age. No longer used in the MIS.

**Investigator:** Name of investigator assigned the case.

**Investigator Determination Code:** Code that is a more detailed code set than the one listed above (see attachment A / B), developed for internal use

**Certifying Officer:** An official in the Employment and Training Administration, United States Department of Labor, who has been delegated the authority granted to the Secretary of Labor to make determinations and issue certifications of eligibility to apply for trade adjustment assistance

**Revised Code:** Y/N – Indicates if a case was revised.

**Revised Date:** Date of the most recent amendment/reconsideration

**Applied for ATAA:** Y/N – Indicates if petitioners applied for ATAA (no longer used).

**Certified for ATAA:** .Y/N – Indicates if petitioning group was determined eligible for ATAA (no longer used).

**Reassigned:** Y/N – Indicates if a case was assigned another investigator

**Reassigned Date:** Date of reassignment

**Worker Group:** Production or Service worker group (obsolete).

**Display:** Y/ N -Corresponds to whether or not the decision will be displayed online for the public on the OTAA website.

**Country 1:** Country affecting worker group

**Country 2:** Country affecting worker group

**Country 3:** Country affecting worker group

**Reconsideration Request:** Reason for reconsideration.
