Re: Complaint re: Acceptance of Excess contributions by the 2014 Muriel Bowser for Mayor Campaign

To the Director of the Office of Campaign Finance,

On Friday, February 24th the Washington City Paper reported that Sanford Capitol, currently the subject of a suit by the District of Columbia, gave campaign contributions in excess of the legal limit to the 2014 Muriel Bowser for Mayor campaign. The Paper reported that Bowser's 2014 campaign Treasurer Ben Soto stated he was unaware of the apparently illegal contribution and according to City Paper did not reply when evidence was offered.

According to Office of Campaign Finance (OCF) public records, it appears that there are 22 similar contributions in excess of the legal limit of \$2,000 made to the 2014 Muriel Bowser for Mayoral campaign. If the reports listed on the OCF website are correct, this amounts to \$31,500 in funds contributed over the legal limit from both individuals and corporations, constituting a violation of campaign contribution limits in D.C. Official Code § 1-1163.33.

We request an investigation by the Office of Campaign Finance into these apparent violations of the District's campaign finance law.


If these reported excessive contributions were not simple reporting errors, but instead reflect a consistent pattern of negligence and failure to comply with the District's campaign finance law, we ask that appropriate corrective actions be taken to ensure that such abuses do not continue.

Attached is the list of entities and individuals that appear to have exceeded the legal limit in their contributions to the 2014 Muriel Bowser for Mayor campaign.
