16 1. My name is Catherine Gellis. I am co-counsel for plaintiff in this case.

17 2. On November 15, 2012, I personally served the summons and amended complaint in this case
18 on defendant Charles Carreon. Mr. Carreon presented oral argument in a case pending before Judge Chen
19 on November 15. I went to Judge Chens courtroom in the Federal Building, 450 Golden Gate Avenue, San
20 Francisco, California, and watch Mr. Carreon present argument. His hearing ended at about 10:50 AM. I
21 waited in the hall for Mr. Carreon to leave the courtroom, which he did by 10:55. When he did, I addressed
22 him by name and said I had a summons and complaint for him. He extended his arm and took them, saying,
