Snapshot of Corporate Donors to Electioneering Groups, 2010 Election

Most groups that conduct electioneering communications or independent expenditures refuse to disclose their donors behind their election ads. But a few of these groups have declared that their major purpose is to influence federal elections, which requires them to register either as political committees (PACs) or “independent-expenditure-only committees” (super-PACs). Super-PACs may receive unlimited contributions from corporations, unions and individuals to pay for independent campaign expenditures, but must disclose their donor sources to the Federal Election Commission (FEC) on a quarterly basis (as well as on a 24-hour basis near the election). It is from these reports that Public Citizen has gleaned a snapshot of corporate political spending this year.

Public Citizen identified about 200 corporate contributors to a mere 29 independent groups that have reported their funding sources to the Federal Election Commission (FEC). Snapshot of Corporate Donors to Electioneering Groups, 2010 Election

Most groups that conduct electioneering communications or independent expenditures refuse to disclose their donors behind their election ads. But a few of these groups have declared that their major purpose is to influence federal elections, which requires them to register either as political committees (PACs) or “independent-expenditure-only committees” (super-PACs). Super-PACs may receive unlimited contributions from corporations, unions and individuals to pay for independent campaign expenditures, but must disclose their donor sources to the Federal Election Commission (FEC) on a quarterly basis (as well as on a 24-hour basis near the election). It is from these reports that Public Citizen has gleaned a snapshot of corporate political spending this year.

Public Citizen identified about 200 corporate contributors to a mere 29 independent groups that have reported their funding sources to the Federal Election Commission (FEC).
